

# 2025 LTC BUDGET

## CONTEXT & PLANNING ASSUMPTONS

- In September 2023, a 4-year operating budget (including capital) with additional 6 year capital budget, as required by The City of Guelph was approved by The Elliott Board of Trustees. The budgets for the fiscal years 2024 to 2027 is referred to as the MYP (multi-year plan)
- Fiscal 2025 Budget is revised to incorporate new information and spending trends from 2024
  - Permanent MLTC funding increases in 2024 drove the need to revise the Fiscal 2025 budget
  - LTC renovation will come on-line in Q4 of 2024; financial impacts of the new home area will be further refined in future budgets (2026) once the impacts of additional LTC capacity on operations is realized
- 2024 budget provided for informational purposes only
- All assumptions for 2025 remained the same as the original budget approved in the Multi-Year Plan
- Planning assumptions for 2025 were approved in May 2024 by Finance and Audit Committee

## CITY OF GUELPH FUNDING

- 2024-2027 Multi-Year Budget for LTC was approved November 29, 2023 by City council
- 2024 included a one-time ask of \$285,574 above planning amount to assist with operational costs related to bed expansion
- 2025 operational funding from the City reduced back to planning amount for 2024-2027
- City funding proposed for 2025 is the same as the amount approved in the 2024-2027 multi-year plan
- In February 2024, City staff were directed to update the 2025 budget such that there was no more than a 4% impact to property taxes, including local boards
- 2025 budget falls within the parameters required by the City of Guelph to achieve the Mayoral Direction
