Flexible Part Time Food Service Worker

Job Overview - The Food Service Worker works to serve quality, nutritious meals, to our residents. The Food Service Worker must ensure that each resident is provided their individual nutritional requirements as outlined by RD. This position must ensure compliance with the dietary services section of the Ministry of Health and Long Term Care Facilities Program.

Job Responsibilities:

- Prepares the dining room for meals
- Plates and serves meals to residents
- All members of the interdisciplinary care team work closely together to address residents' nutrition and hydration needs and to create a pleasurable dining experience.
- Use Kardex, daily to ensure they are in compliance with the regulations of the MOHLTC providing residents' diet, special needs and food/beverage preferences.
- Performs dish ware-washing duties
- Maintains a clean and sanitized work area
- Prepares nourishment cart
- Other duties as required.

Qualifications:

- Possesses a Food Service Worker Certificate or in process of completion (within 2 years)
- Safe Food Handling Certificate and commitment to maintain/renew based on Public Health's requirements.
- Annual Training, complete assigned knowledge program.
- Documentation indicating that you have received all appropriate immunizations, including administration of an
 annual influenza vaccine and a recent TB skin test which indicates that you are able to perform the essential
 duties of the position without harm to yourself or risk of harm to others.
- Vulnerable Sector Search Criminal Record Check.
- Mature, responsible and organized individual capable of performing duties as assigned.
- Able to work independently and part of a team.
- Must be able to work, days, evenings, and weekends as required.
- Capable of reading and writing English.

Requirements of the Job:

Physical: Repetitive walking, bending, pushing, and lifting, standing for prolonged periods.

Emotional: Can be emotionally draining when dealing with frail and aging residents

Hours: Flexible Part Time, includes days, afternoons, evenings, weekends and Public Holidays.

While we have an immediate need, the successful candidate must demonstrate a commitment to The Elliott Community's mission and values. We offer a flexible work environment, competitive compensation package and participation in the OMERS pension plan and extended health and dental benefits for qualifying staff.
