- Consult Kardex daily to ensure compliance with the regulations of the MOHLTC providing residents' diet, special needs and food/beverage preferences.
- Performs dish ware-washing duties.
- Maintains a clean and sanitized work area.
- Prepares nourishment cart that respects preferences and offers choice.

- Possesses a Food Service Worker Certificate or current enrollment in the program with completion within 2 years.
- Students in the Applied Human Nutrition Program.
- Safe Food Handling Certificate and commitment to maintain/renew based on Public Health's requirements.

- Must be able to work, days, evenings, and weekends as required.
